Highlights of 2022/23

The Sydney Real Tennis club is delighted to report that significant progress has been made during the past 12 months:

- fund-raising has now reached A\$2.6 million, comprising private donations from around 280 individuals and a grant from the NSW Government
- the Breaking of the Ground Ceremony was held in June, coinciding with International Tennis Day
- final revisions to the 2021 planning approval are being considered by Hornsby Council (this includes relocating rather than demolishing the croquet pavilion and a repositioning of the lift so that it can service the upper floor of the club)
- a builder has been appointed, and work is underway to obtain a Construction Certificate and to firm up the cost of the project
- construction is expected to start early in 2024, and if all goes to plan the court will be ready for play in the last quarter of 2024

These achievements have been the culmination of thousands of hours of planning, research, documentation and lobbying undertaken pro-bono by a small group of real tennis players in Sydney.

Invaluable support has been provided by the clubs in Melbourne, Hobart, Ballarat and Washington as well as the Australian Real Tennis Association, and peak bodies of real tennis in the UK and USA. Donations have been received from real tennis players around the world.

Interstate real tennis matches

During the year the Sydney team travelled interstate to compete against each of the other Australian real tennis clubs. While the matches were keenly fought, they are also very sociable weekends, and Sydney always enjoys a warm reception both on and off the court.

For the record, here are the results:

- Ballarat Tennis Club (Ballarat, May 2023) Sydney won the Doug Grant Trophy by 9 matches to 7
- Wanderers (Ballarat, May 2023) Sydney won the match by 4 matches to 3
- **Hobart Real Tennis Club (Hobart, February 2023)** Sydney won the Sydney Hobart Trophy by 11 matches to 7
- Royal Melbourne Tennis Club (Melbourne, September 2023; 25th anniversary year) Melbourne won the Barry Toates Trophy by 16 matches to 4
- **Melbourne Cricket Club (Melbourne, September 2023)** Sydney won the Paul Wheeler Trophy by 8 matches to 6
- Jesters (Melbourne, September 2022) Jesters won the match by 6 matches to 2



Real tennis Open Day (Cheltenham, June 2023)

Invitations went out to local schools and residents to come to CRC to see and hear about the plans for a real tennis court at Cheltenham and to enjoy an afternoon at the club.

Local Mayor Phillip Ruddock gave an opening address and there were presentations from Chris Cooper, Michael Fitzgerald, and Sav Cremona about the real tennis project. Alastair Curley from the Australian Real Tennis Association flew up from Melbourne for the occasion and made an entertaining speech highlighting how important the new court in Sydney will be to the sport in Australia.

Food and drinks were served, and there were prizes for hitting a real tennis ball over the net and into the "grille". It was a fabulous day that really showcased the best of Cheltenham.



Real Tennis Trivia Challenge (Cheltenham, August 2023)

Another fun evening as always at CRC, with people dressing up and playing silly games, which this year included building a real tennis court out of Lego. The theme of the evening was: "Can we build it? Yes we can!"

Congratulations to Sav Cremona's Hammerheads team who took out the overall trivia prize. As in previous years, the event was presided over by red-hot quiz master Mike Jury.



Croquet Challenge (Cheltenham, April 2023)

The Real Tennis Section fielded a team of 30 mostly novice players for an afternoon of croquet at the club, to meet other CRC members, and enjoy the bar and restaurant facilities of Molly's Pavilion.

All credit to Anne Woods and her friends from the ever-friendly Croquet Section who were fantastic hosts. The afternoon showers failed to put a dampener on proceedings, and did little to deter the hardy croquet players.

No scores were recorded; in the end the weather was the winner!



UK Jesters lawn tennis match (Cheltenham, November 2022)

The Jesters (a nomadic club headquartered in the UK, but with 3,000 members worldwide) sent a strong team of 12 men and women to Australia in November to play various sports, including real tennis. Their first stop was Sydney, where Sydney Real Tennis took them on at Padel, went sailing with them on Sydney Harbour and then enjoyed a splendid afternoon of tennis and croquet at Cheltenham.

The visitors were duly appointed ambassadors for Cheltenham, and on their return to the UK have helped to raise a substantial number of donations for the new court.



The Tennis Challenge (postponed to early 2024)

The 2023 Tennis Challenge has been rescheduled to early 2024, and we are confident will provide another great afternoon's fun and sport. This event between the Real Tennis and Tennis Sections at Cheltenham is held annually, with the plan being to alternate each year between tennis and real tennis.

NOTE 1: STATEMENT OF ACCOUNTING POLICIES

The financial report is a special purpose financial report prepared in order to satisfy the accounts preparation requirements of the Association Incorporations Act (NSW). The committee has determined that the Association is not a reporting entity.

Australian accounting standards and other authoritative pronouncements have not been applied to these financial statements.

The financial report has been prepared on an accruals basis using historic costs and does not take into account changing money values.

NOTE 2 BUILDING EXPENSES

The Club has chosen to treat expenditure incurred on the design and construction of a real tennis court as an expense in the profit and loss account rather than capitalising them to the balance sheet.

NOTE 3 IN-KIND CONTRIBUTIONS
